## SECRETARY / CORRESPONDENCE

## NEW WEBSITE:

Tom Grimston outlined the details regarding the launch of the new WAVGA website. Members had a number of questions, mainly regarding the initial setup, and these were responded to.

Kevin Essing asked if it would be possible to have an indicator as to whether the member is riding in a cart. This will be looked at as a future enhancement to the system.

## GENERAL BUSINESS:

1. David Scott outlined the planning for next year's fixtures. In particular the SW trip will follow the Country vs City fixture at Bunbury early in March. 50% of the fixtures are locked in so far and David is meeting next week with the new captain and Vice captains to hand over and finalise the fixture list.
2. Brian Graham suggested that with shot gun starts the field is organised so that there is only 1 group following a par 3 and 3 groups following a par 5.
3. Morgan Jensen requested more games to be scheduled north of the river.
4. Kevin Essing spoke about the progress at Lakelands. The new club house is now complete and they have a new corporate golf manager. Approaches have been made for the Vets to return to playing at Lakelands but with a suggested fee of \$50 this is not possible at present. Negotiations will continue in an attempt to agree on an acceptable green fee.
5. David Scott advised that negotiations are continuing with Royal Fremantle. A green fee of \$55 has been suggested and this has been rejected. Karrinyup are in the pool at a green fee of \$80.
6. Richard Pace wished to thank the committee for steering us through a turbulent year and getting us to where we are today.


